### OBJECTIVE

The objective of this call is to give value and visibility to the projects and initiatives carried out by the municipalities and councils of the national municipalities in the field of Smartcities, as well as their contribution to improving the quality of life of their citizens.

### REQUIREMENTS FOR PARTICIPATION

Each of the following requirements must be fulfilled:

1. Be a national municipality
2. Complete the form correctly
3. The project or initiative must be implemented or in progress
4. Active participation in the Networking Agenda mode at Greencities&S-Moving 2024

### CATEGORIES

The following categories are required:

1. Municipalities up to 5.000 inhabitants.
2. Municipalities with a population between 5.000 and 50.000.
3. Municipalities with more than 50.000 inhabitants.

## EVALUATION COMMITTEE

The **Evaluation Committee** is made up of representatives from the following organisations:

## SELECTION CRITERIA

The following criteria will be taken into account by the evaluation committee for the pre-selection of candidates

- Participation of citizens in the implementation of the project
- Studies and forecasts of citizens' quality of life indices
- Degree of innovation and technology used in the projects
- Commitment and involvement in the following SDGs
  - Health and well-being
  - Clean water and sanitation
  - Affordable and clean energy
  - Industry, innovation, and infrastructure
  - Sustainable cities and communities

## SELECTION PROCESS

*REGISTRATION* (until 31 August, 23:59, 2024)

Interested cities must **complete the pre-registration** on the official Greencities&S-Moving website. Once pre-registered, they must access the private area of the platform and **fill in the specific form**.

### *SELECTION PHASE* (3 September to 12 September 2024)

The evaluation committee will select **3 finalist cities per category**, with a total of 9 cities represented.

The Organisation will contact the selected cities **from 13<sup>th</sup> September 2024. They must confirm or decline before 18<sup>th</sup> September 2024** in order to retain the right to the benefits acquired. If one of the selected cities cannot participate or does not confirm before the deadline, it will lose the right to participate and the organisation reserves the right to contact the next best rated city/cities.

The selected projects will be presented at Greencities&S-Moving on **25<sup>th</sup> September 2024**. The pitch will take place in front of a specialised audience made up of the evaluation committee, experts and reference bodies in the field of smart cities. The winning cities will be announced at the awards ceremony on 25 September 2024.

## **BENEFITS OF PARTICIPATION**

- Presentation of the project with a duration of 8 minutes (5 min pitch + 3 min questions) in front of experts and reference entities in Smartcities.
- Branding:

  - Visibility in RRSS as winner city of Greencities & S-Moving 2024.
  - Mention in press release.

- Deadline to confirm participation in the event: by September 18<sup>th</sup>, 2024.
